- **B.** Approve the May 02, 2023 Executive Session Meeting Minutes. Discussion and possible action to approve the executive session meeting minutes for last month. - **C. Ratify Expenses for May 2023.** Discussion and possible action to ratify the expenses for last month. Clay Vanderslice made a motion to ratify the expenses for last month, John Kai, Jr., seconded the motion. All in favor, motion passed. Kai Y; Vanderslice Y; Vasquez Y; Sherrill- Y.
- D. *Westview Estates, T19N, R22W, Section 14; Transfer Request of Preliminary Water Allocation, previous extensions from October 4, 2022 and January 3, 2023 regular meeting. The preliminary allocation is 30.60-acre feet of water. Discussion and possible action regarding this request. Staff, District Council, and the Board of Directors discussed and approved each item separately.

- a. Transfer a portion of the preliminary water allocation to 5 parcels for Parcel Plat recorded July 8, 2022; APN: 229-12-055 (Parent Parcel) divided into APN's 229-12-065 (2.375 acres); 229-12-066 (2.248 acres); 229-12-067 (4.637 acres); 229-12-068 (4.637 acres) and 229-12-069 (4.643 acres). Discussion and possible action to approve a final water allocation of 1.144-acre feet of water (5.72-acre feet total) per parcel and a deed restriction on each parcel. Vince Vasquez made a motion to approve the final water allocation with a requirement to record the covenant restrictions for each parcel, Clay Vanderslice seconded the motion. All in favor, motion passed. Kai Y; Vanderslice Y; Vasquez Y; Sherrill Y.
- b. Transfer a portion of the preliminary water allocation to a new project referred to as Joy Lane Twin Homes to be developed on APN: 227-16-031A for 16 residential units on 8 lots and 1 lot for a Retention Basin (6.24-acre feet total) with a 12-month extension. Discussion and possible action for the transfer and extension. Clay Vanderslice made a motion to approve the transfer of preliminary water allocation to this project with a one (1) year extension which will expire on June 06, 2024, Vince Vasquez seconded the motion. All in favor, motion passed. Kai Y; Vanderslice Y; Vasquez Y; Sherrill Y.
- C. Transfer a portion of the preliminary allocation to a new project referred to as 4-Joy Development for four (4) residential units of water to APN: 227-02-094. Parcel Plat pending recordation (1.96-acre feet total) with a 12-month extension. Discussion and possible action for the transfer and extension. Vince Vasquez made a motion to approve the transfer of preliminary water allocation to this project with a one (1) year extension which will expire on June 06, 2024, Clay Vanderslice seconded the motion. All in favor, motion passed. Kai Y; Vanderslice Y; Vasquez Y; Sherrill Y.
- d. Transfer a portion of the preliminary water allocation to APN: 229-12-075 (2.058 acres) with a deed restriction. (1.03-acre feet total) Discussion and possible action to approve a final water allocation. Discussion and possible action to approve a final water allocation of 1.03-acre feet and a deed restriction on the parcel. Vince Vasquez made a motion to approve a final water allocation with a requirement to record the covenant restrictions for this parcel, Clay Vanderslice seconded the motion. All in favor, motion passed. Kai Y; Vanderslice Y; Vasquez Y; Sherrill Y.
- e. Extension request for the remaining 15.65-acre feet of Preliminary water. Discussion and possible action to approve extending the extension of time an additional 6 months. District Counsel, Michael Pearce, suggested to the Board of Directors that they consider a new policy which will allow developers, holding a current preliminary water allocation that is recognized by the District to be in good standing, to be allowed to sell or transfer those allocations to other

developers or individuals needing a water allocation. This policy would be similar to the policy allowing AG to urban transfers. This new policy could be developed and ready for review at the July 11, 2023 regular board meeting and then possible action on it at the August 1, 2023 regular meeting. Clay Vanderslice made a motion to approve the extension request of the preliminary water allocation for six (6) months which will expire on December 06, 2023, Vince Vasquez seconded the motion. All in favor, motion passed. Kai – Y; Vanderslice – Y; Vasquez – Y; Sherrill – Y.

- **E. Call of Election for Division III Director.** Discussion and possible action regarding Resolution 2023-02 Call of Election of Division III Director. The election date is November 14, 2023. Staff reviewed Resolution 2023-02 with the Board of Directors. Clay Vanderslice made a motion to approve the Call of Election, John Kai, Jr., seconded the motion. All in favor, motion passed. Kai Y; Vanderslice Y; Vasquez Y; Sherrill Y.
- **F. Fiscal Year June 2023- July 2024 Budget.** Discussion and possible action to approve the June 2023 July 2024 Budget. (Previously discussed at the April 04, 2023 & May 02, 2023 Regular Meeting) Staff reviewed the budget with the Board of Directors. Clay Vanderslice made a motion to approve the budget, Vince Vasquez seconded the motion. All in favor, motion passed. Kai Y; Vanderslice Y; Vasquez Y; Sherrill Y.
- G. *July 01, 2023 Comprehensive Fee Schedule and Payment Rules.

 Discussion and possible action to approve the July 01, 2023 Comprehensive Fee Schedule and Payment Rules. (Previously discussed at the April 04, 2023 & May 02, 2023 Regular Meeting) Staff reviewed the comprehensive fee schedule with the Board of Directors. Vince Vasquez made a motion to approve the comprehensive fee schedule, John Kai, Jr., seconded the motion. All in favor, motion passed. Kai Y; Vanderslice Y; Vasquez Y; Sherrill Y.
- **H. Mohave County 2023 Tax Levies and Rates Certification.** Discussion and possible action to approve the 2023 Tax Levies and Rates Certification. (Previously discussed at the April 04, 2023 & May 02, 2023 Regular Meeting) Staff reviewed the tax levies and rates certification with the Board of Directors. Clay Vanderslice made a motion to approve the tax levies and rates certification, John Kai, Jr., seconded the motion. All in favor, motion passed. Kai Y; Vanderslice Y; Vasquez Y; Sherrill Y.
- I. HintonBurdick CPA's & Advisors. Discussion and possible action to approve the engagement letter of HintonBurdick for our fiscal year ending June 30, 2023 financial review. Staff reviewed the engagement letter with the Board of Directors

and advised that we paid \$4,085.91 last year and this year's rates have increased and will be approximately \$4,500 to \$5,250 for this year. Clay Vanderslice made a motion to approve the engagement of HintonBurdick CPA's and Advisors for our financial review, Vince Vasquez seconded the motion. All in favor, motion passed. Kai – Y; Vanderslice – Y; Vasquez – Y; Sherrill – Y.

- **J.** *2023 System Conservation Agreement. Discussion only. District Counsel, Michael Pearce, advised the Board of Directors that the District has a meeting scheduled with Reclamation on Thursday morning to discuss the delay in receiving 2023 System Conservation Agreement (SCIA).
