F. Colorado River Properties, LLC; Petition for Inclusion of Parcel 216-14-012 into the District. Discussion and possible action regarding the request. (Previously Discussed at the April 07, 2026, Regular Board Meeting and published in the local paper April

29, 2026, May 6, 2026 & May 13, 2026). Staff reviewed the Petition for Inclusion of Parcel 216-14-012 and the publishing requirements that have been satisfied according to A.R.S.48-2941. District Counsel, Mr. Michael J. Pearce explained the details of the request and the District boundary Map. No members of the public addressed the board to show cause why the petition should not be granted. This item will be brought to the board of directors at the July 07, 2026, board meeting for consideration and possible approval.

G. Sun Valley Unit II Tract 4185C; T18N, R22W, Section 01; APN(s) 225-59-020; Request for a 24-Month Extension of Preliminary Water Allocation for Phase C for 35 Residential Lots. Discussion and possible action regarding the request. Staff reviewed the extension request with the board of directors and recommended the 24-month extension. Vince Vasquez made a motion to approve the extension request for 24 months; Clay Vanderslice seconded the motion. All in favor, motion passed. H. 2026/2027 Annual Budget, Comprehensive Fee Schedule, and Payment Rules. (Previously Discussed at the April 07 & May 05, 2026, Board Meeting) Discussion and possible action regarding the 2026/2027 Annual Budget. Staff reviewed the 3 versions of the budget with the board of directors. There was detailed discussion amongst the board and the 3rd option, which was a straightforward share of budget fee increase of 60% to all users was chosen. Vince Vasquez made a motion to approve the annual budget based on the 3rd option (60% increase to all users); John Kai, Jr., seconded the motion. All in favor, motion passed. I. 2026/2027 Comprehensive Fee Schedule. (Previously Discussed at the April 07 & May 05, 2026, Board Meeting) Discussion and possible action regarding the 2026/2027 Comprehensive Fee Schedule. Based on the previously approved budget, staff reviewed the 60% increase version of the comprehensive fee schedule with the board of directors. Perry Muscelli made a motion to approve the comprehensive fee schedule incorporating the 60% increase option; Vince Vasquez seconded the motion. All in favor, motion passed. J. 2026/2027 Payment Rules. (Previously Discussed at the April 07 & May 05, 2026, Board Meeting) Discussion and possible action regarding the 2026/2027 Payment Rules. Based on the previously approved budget, the board of directors do not see a need to adjust the payment rules at this time. Perry Muscelli made a motion to approve the payments rules using the same version that has been in place; Vince Vasquez seconded the motion. All in favor, motion passed. K. 2026/2027 Mohave County Tax Levies and Rates Certification. (Previously Discussed at the May 05, 2026, Regular Board Meeting). Discussion and possible action regarding the Mohave County Tax Levies and Rates Certification. Based on the previously approved budget, staff reviewed the 60% increase version of the Tax Levies and Rates Certification with the board of directors. Vince Vasquez made a motion to approve the 60% increase for the Tax Levies and Rates Certification; Perry Muscelli seconded the motion. All in favor, motion passed. Kai – Y; Muscelli – Y; Vanderslice – Y; Vasquez – Y; Sherrill – Y.

L. **Reclamation's Lower Colorado River Basin Conservation and Efficiency Program Bucket 1 Extension of SCIA's for system conservation in 2027 and 2028. Discussion and possible action regarding participation in the extension of system conservation. District Counsel, Mr. Michael J. Pearce, shared that the District has been extended the opportunity to participate in system conservation for 2027/2028 under the Bucket 1 SCIA Program. The District had a meeting with Reclamation on some of the details of the program and submitted a proposal last week with Reclamation regarding the specific terms of quantifying conservation yield. That proposal is currently under review by Reclamation. Mr. Pearce also shared that we have interest from one of our local utilities, EPCOR, in trying and firm water supplies for their existing constituents within the District and along the Colorado River. The District has had another proposal to participate in conservation programs with other stakeholders. No action was taken on the matter.

9. CALL THE PUBLIC. *Those wishing to address the Board at the Call to the Public regarding matters not on the Board agenda can request to do so at this time. Action Taken as a result of public comments will be limited to responding to criticism, referral to staff, or placing a matter on a future Agenda. Comments are restricted to items **NOT** on the Regular Agenda and must relate to matters within the jurisdiction of the Board.* Bill from Bella Vista Community spoke about desalination plants in San Diego and negotiations going on with the state. Chip shared his thoughts on the high expenses with desalination. Perry Muscelli shared it cost about \$3,000 an acre foot to develop.
